

DETAILED EXPLANATION OF THE PUBLIC TRANSPORT OFFER IN CONNECTION WITH MOUNTAIN RAILWAY TICKETS, INCL. LOCAL TRAVELCARDS, TOPCARD AND GRAUBÜNDENCARD

Public transport with mountain railway included in Davos fare network from winter season 21st November 2024 (depending on the opening of the 2024/25 winter season)

TARIFF ASSOCIATION DAVOS

A new solution has been agreed for Davos Mountain railway tickets and travelcards. From the 2024/2025 winter season, mountain railway tickets will be valid in zones 400, 410, 420 and 430 of the fare networks with restrictions.

DESCRIPTION

Extent of use:

• Davos fare network zones 400, 410, 420, 430 (Davos Laret to Davos Glaris with Pischabahn) on VBD, PostBus and RhB (2nd class)

Period of validity:

• During the operating hours of the mountain railways (expected start Parsenn on 21.11.2024)

Restrictions:

- Is limited to the outward and return journeys to the valley stations of the DKM mountain railways while taking part in winter sports.
- Day or half-day tickets are only valid on the day to a certain extent.
- A subsequent refund/payment of the travel ticket is no longer possible.
- For the use of public transport when not taking part in winter sports or during leisure time, regular tickets must be purchased e.g. annual season ticket. There are separate discounts for residents of the municipalities of Klosters and Davos (www.invia.ch/davos or www.invia.ch/klosters).

FURTHER INFORMATION

The same conditions apply to ESA, TopCard and graubündenCARD. For the ticket inspection, it is important to show a valid mountain railway ticket for the actual day (if in doubt, show the sales receipt) and that winter sports are clearly being practised.

Guests staying in Davos on holiday can use public transport in Davos in zones 400, 410 + 420 without restriction with the guest card.

SHOW SALES RECEIPT

When purchasing via a web shop or if the mountain railway ticket is loaded onto a third-party data carrier, a purchase receipt must be presented (digital or paper form). Third-party data carriers include, for example, SwissPass, credit cards or cards from other mountain railway regions (list not exhaustive).

Inclusion of public transport with mountain railway in the Klosters fare network for residents of the municipality of Klosters from winter season 21.11.2024

(depending on the opening of the 2024/25 winter season)

TARIFF ASSOCIATION KLOSTERS

Public transport in Klosters (TVK zones 200/210) and the RhB route from Klosters to Davos Platz (2nd class) are included for residents of the municipality of Klosters with a valid mountain railway ticket.

DESCRIPTION

Extent of use:

 Davos fare network zones 400, 410, 420, 430 (Davos Laret to Davos Glaris with Pischabahn) on VBD, PostBus and RhB (2nd class)

Period of validity:

• During the operating hours of the mountain railways (expected start Parsenn on 21.11.2024)

Restrictions:

- A valid resident's ID card from the municipality of Klosters must be presented at the inspection.
- Is limited to the outward and return journey to the valley stations of the DKM mountain railways while taking part in winter sports.
- Day or half-day tickets are only valid on the day to a certain extent.
- A subsequent refund/payment of the travel ticket is no longer possible.
- For the use of public transport when not taking part in winter sports or during leisure time, regular tickets must be purchased e.g. annual season ticket There are separate discounts for residents of the municipalities of Klosters and Davos (www.invia.ch/davos or www.invia.ch/klosters).
